The PhD defence

It is the Graduate School's task to organise the PhD defence in such a way that it best meets the needs and wishes of the PhD student, that is, a PhD defence with all assessment committee members physically present at the defence. Therefore, the hybrid PhD defence option should be used only in special cases.

There may be cases, however, where an assessment committee member does not have the opportunity to be physically present. In those cases, it can be approved that one (and only one) of the assessment committee members can participate online. Insert committee member name and state the reason on the following page if this is the only option. The Head of programme must approve. If you have any questions, please contact the Head of programme.

If there are exceptional cases where more than one assessment committee member may not have the opportunity to be physically present, it must be approved by the Head of school.

Rules of Impartiality for members of PhD assessment committees

- 1. Members of assessment committees must comply with general administrative practice concerning impartiality, for instance they may not have a personal or financial interest in the outcome of the PhD defence. Furthermore, the specific rules below concerning publications must also be observed (these correspond to the rules of the Danish Research Councils).
- 2. Members of assessment committees may not have prepared, submitted or published any publications with the PhD student. Neither may they have any publications under present preparation.
- 3. External members of assessment committees may not have prepared, submitted or published any publications with main supervisor or co-supervisor(s) within the past 5 years. Neither may they have any publications under present preparation.
- 4. The head of PhD school can grant exemption from the above rules under very specific circumstances.
